Pursuant to the Freedom of Information Act (FOIA)<sup>1</sup> and the Federal Energy Regulatory Commission's (Commission) regulations, 18 C.F.R. § 388.112(d) (2020), you are hereby notified that an individual has filed a request for material that the North American Electric Reliability Corporation (NERC) has submitted as privileged or confidential in connection with, among other dockets, NP11-266; NP11-270; NP12-12; and RC12-11.

Because NERC has asserted a privileged and/or confidential interest in the information requested, we are soliciting your comments on whether release of the information is required under the FOIA. We are also providing a copy of this notice to the concerned URE(s), which you may coordinate with in preparing your responses.<sup>2</sup> We also ask that you advise the relevant URE(s) of this notice to ensure receipt. In this regard, responses, if any, should comment only on the following:

- The disclosure of the identity of the relevant URE(s) *only* in connection with the above-referenced listed docket(s).

The Commission will not be persuaded by conclusory statements or assertions as to why the identity of a URE deserves protection. The Commission may construe a non-response as evidence that you do not object to releasing the name.
